

# OMA Call for Members for the 2021 Nominations Committee



## RESPONSIBILITY

The mandate of the Nominations Committee is to ensure impartiality and responsibility in the soliciting and identification of nominees for Council, and to represent the interests of the membership in these responsibilities. The responsibility to select candidates best suited to lead the Association requires thoughtful planning and attention to skills / areas of expertise currently required by the Council for its Strategic Plan implementation. The Nominations Committee reports to the membership of the OMA, generally at the Annual General Meeting. It operates at arms-length from Council, but is guided by the criteria established by Council for the skills which it will require over the next term.

## TERM OF OFFICE

The term of office is one year from the date of the Annual General Meeting.

## TIME COMMITMENT

The Nominations Committee will notify the membership that nominations are open, review and confirm the eligibility of each candidate, and contact and confirm the interest of all candidates in standing for election. The Nominations Committee will bring forward the slate of Council nominations for election by the membership at the 2021 Annual General Meeting.

## NOMINATION

The Nominations Committee may consist of up to five members. It shall include the Past-President, one member selected from the Council and no more than three members elected by the membership at the Annual General Meeting.

Nominees must be individual members of the OMA in good standing. The nominator must also be a member in good standing. The nominees for membership on the 2021 OMA Nominations Committee will be announced at the 2020 Annual General Meeting on November 5, 2020 for election by the membership.
